PUBLIC HEARING

CUP-261M(1), The Local

The applicant requested approval of a modification to a previously approved Conditional Use Permit (CUP-261) to allow for the sales of wine, beer, and distilled spirits for on-site consumption under a Type 48 Alcoholic Beverage Control (ABC) license at an existing drinking establishment. The applicant currently operates under a Type 42 ABC license, which is limited to the sales of beer and wine only, for on-site consumption. As with a Type 42 ABC license, food service is not required under a Type 48 ABC license.

Chairman Edsall declared the **PUBLIC HEARING OPEN**.

Chairman Edsall continued the Public Hearing to July 2, 2019. The Public Hearing will remain open until the next meeting.

PUBLIC HEARING

CUP-395, Camarillo Center for Spiritual Living

The applicant withdrew their request for the approval of a Conditional Use Permit (CUP-395) to occupy two 1,200-square-foot units to be utilized as a church use in an existing commercial office building, offering Sunday services between 9:00 a.m. and 10:00 p.m., classes between 6:00 p.m. and 10:00 p.m. on Wednesday through Friday, and classes and services on Saturdays between 9:00 a.m. and 9:00 p.m.

Chairman Edsall informed staff that at the request of the applicant, the item was withdrawn and required no further action.
